<b>Trip Cancellation &amp; Trip Interruption</b> 100% of Reservation Cost	Pays for non-refundable payments and certain extra costs if your trip must be canceled or interrupted for unexpected injury, sickness, death and other specific reasons listed in the Description of Coverage. Pre-Existing Conditions are waived provided you purchase the plan by final payment and are able to travel at the time you make payment for the plan.
<b>Travel Delay</b> \$600	Provides coverage if you are delayed during your trip for more than 12 hours due to a covered reason.
